The District is committed to student security from campus crime. While the District cannot serve to insure the safety of students from the criminal conduct of others, the District believes that recognizing the presence of criminal activity in society in general and the potential for such activity on college campuses, can serve to educate students about the need to be familiar with security precautions and the need to report campus crime.

The College shall promulgate procedures in conformance with this policy which shall include the following components:

1. Procedures for students and others to report criminal actions or other emergencies on campus.
2. Procedures for institutional response to reports of criminal actions on campus.
3. A statement concerning the security of campus facilities and access to those facilities.
4. A statement describing campus law enforcement, the enforcement authority of District public safety personnel, and the means by which prompt reporting of all campus crime to campus and other appropriate local police is encouraged.
5. A description of the type and frequency of programs designed to inform students and employees about campus security procedures and practices and to encourage them to be responsible for their own security and the security of others.
6. A description of programs designed to inform students and employees about the prevention of crime.
7. Statistics regarding the following criminal offenses reported to campus public safety authorities or other police agencies: murder, rape, robbery, aggravated assault, burglary, and motor vehicle theft.
8. A statement concerning monitoring criminal activity of any off-campus students organizations where those organizations are recognized by the District as student organizations whose participants are District students.
9. Statistics regarding the number of arrests for the following crimes occurring on campus: liquor law violations, drug abuse violations, and weapons possessions.
10. A statement which affirms the District's ban on the possession, use, or sale of alcoholic beverages, and illegal drugs on campus.
